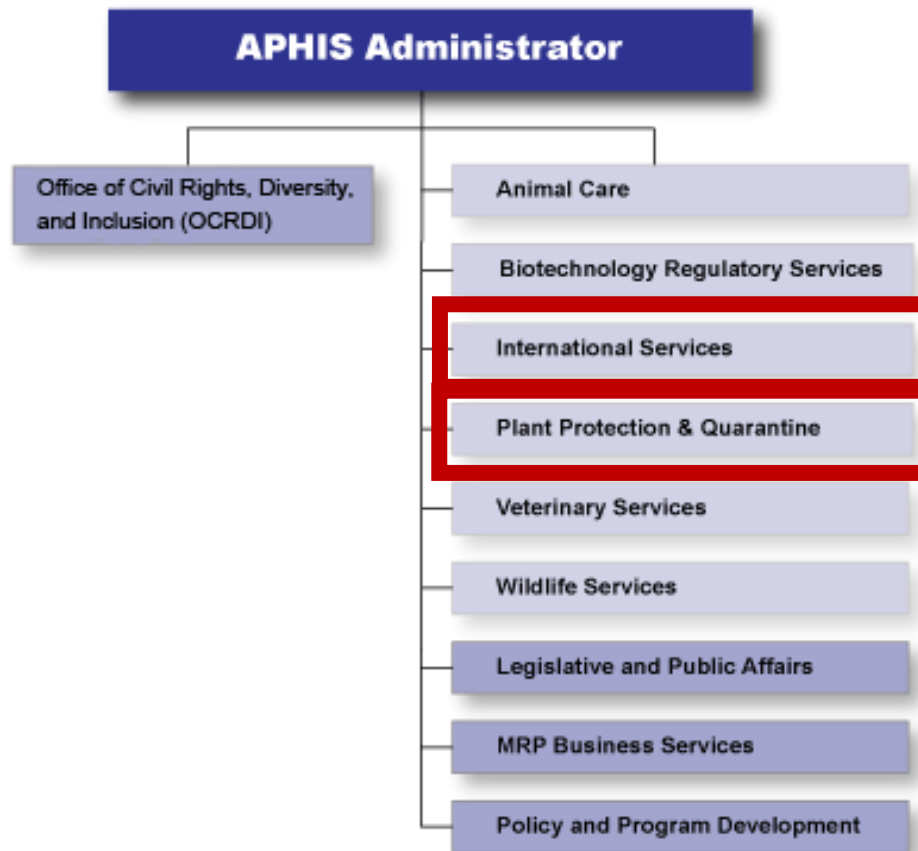

Why are we here? Overview

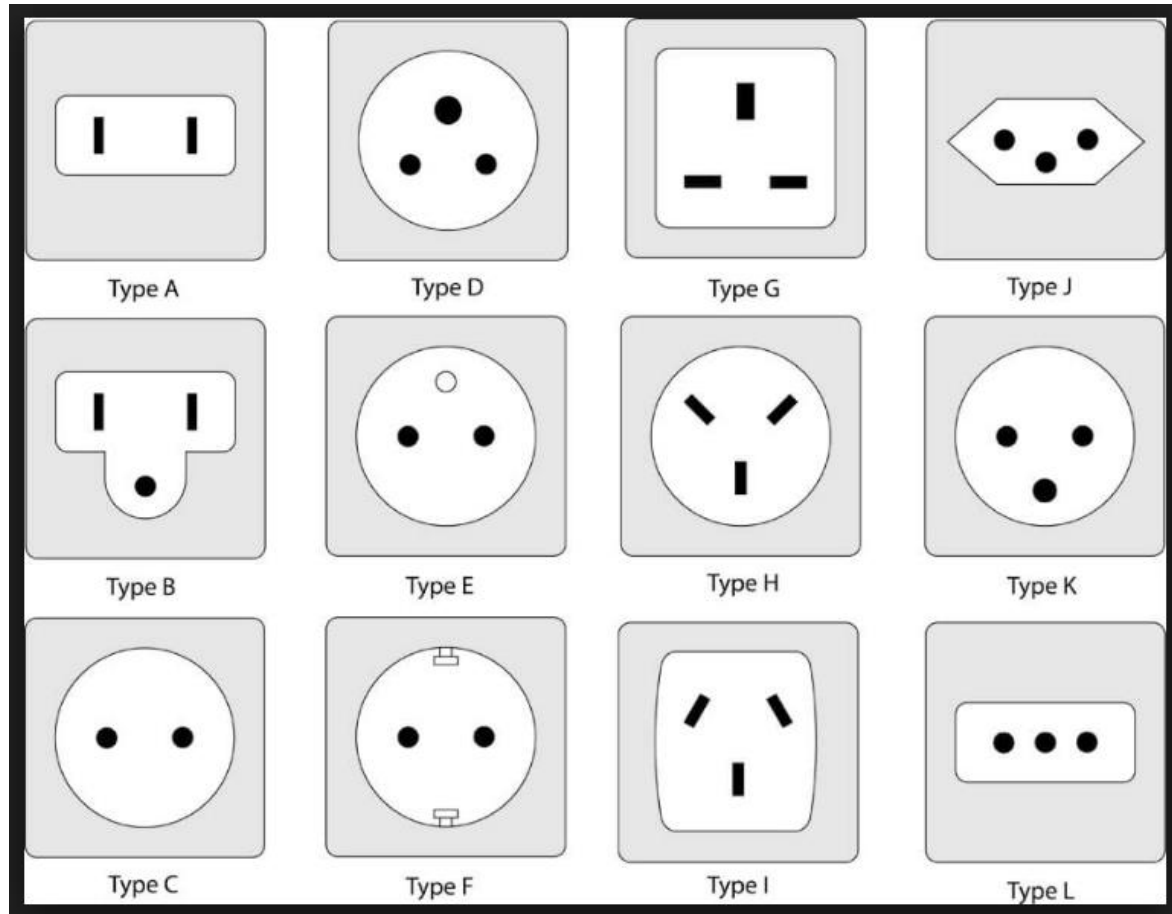
- Project submitted in July 2017 - to design and deliver “Americas focused” workshop to promote implementation of ISPM 38
- Why?
 - ISPM 38 adopted in 2017
 - Exponential growth of seed trade
 - Seed production practices are global = challenges to traditional 1-county 1-commodity approaches

Workshop Goals

- ***Address ISPM 38 guidance*** on identifying, assessing and managing pest risks associated with the international movement of seeds
- ***Increase capacity in the Americas***
- ***Work towards harmonization***
