### NAPPO Executive Director and Executive Committee attend the 11<sup>th</sup> Session of the Commission of Phytosanitary Measures (CPM 11)

The CPM 11 was held from April 4–8, 2016, at the Headquarters of the Food and Agriculture Organization of the United Nations in Rome, Italy. Over 360 participants representing 136 countries, 12 international organizations, and 4 nongovernmental organizations attended the meeting. In addition to NAPPO, six other Regional Plant Protection Organizations (RPPOs) were in attendance (EPPO, NEPPO, OIRSA, COSAVE, APPPC, and IAPSC).

The theme for the CPM 11 was *Plant Health and Food Security*. Mr. Daniel Gustafson, Deputy Director General of FAO for Operations, delivered the opening remarks; Mr. Jingyuan Xia, Secretary to the IPPC, made a presentation on the role of the



IPPC in the next five years; and Prof. Rudy Rabbinge from the University of Wageningen delivered the keynote address. The meeting was chaired by Dr. Kyu-Ock Yim, outgoing CPM chair.

The CPM 11 completed 18 scheduled Agenda items, offered one pre-CPM training on implementation of International Standard for Phytosanitary Measures (ISPM) 32— *Categorization of commodities according to their pest risk*—and organized seven side sessions on emerging pests and new technologies for plant health. Nine new international standards, two ISPMs—

Determination of host status of fruit to fruit flies (Tephritidae) and 2014 Amendments to the Glossary of Phytosanitary Terms (ISPM 5)—two Phytosanitary Treatments, and five Diagnostic Protocols were adopted by the Contracting Parties during the meeting. There was an afternoon Special Topic Session on Phytosanitary Risks and Sea (intermodal) Containers to inform and decide on the fate of a draft ISPM on this topic. During the week, participants were able to vote on the submissions to the second IPPC photo contest on the Shocking Impacts of Pests.

Stephanie Bloem, NAPPO Executive Director and current chair of the Technical Consultation (TC) among RPPOs, delivered a presentation to the CPM 11 on the results of the 27<sup>th</sup> TC among RPPOs, which was held in Memphis, Tennessee, immediately following the conclusion of the 39<sup>th</sup> NAPPO Annual Meeting.

The Twelfth Session of CPM (CPM 12), with the theme *Plant Health and Trade Facilitation*, will be held from April 5–11, 2017 in Incheon, Republic of Korea. This will be the first time that the CPM will be held outside of Rome. In his concluding remarks, the IPPC Secretary urged the IPPC community to attend CPM 12, and to plan well ahead to ensure that all preparations for CPM 12 are timely.






# Plans to Celebrate the 40<sup>th</sup> Anniversary of NAPPO at the 2016 NAPPO Annual Meeting

The meeting will be held at the beautiful and historic Marriott Chateau Champlain Hotel right in the middle of Montreal's downtown area. Hotel accommodations and meeting rooms

are fantastic! The hotel is close to shops, restaurants, and entertainment of all kinds.

Kudos go to our colleagues from USDA-APHIS-PPQ who designed the logo for the meeting, which depicts the beautiful Montreal skyline. As you may have noticed, all of the webpages for the meeting, including those for registration, booking hotel accommodations and choosing your meals are now available on the NAPPO website—<u>www.NAPPO.org</u>. Kudos to Alba Campos for her hard work with the webpages and to Nedelka Marin-Martinez for translating the webpages to Spanish.

The Symposium topic for this year will be **Building on industry experience and best practices for efficient alternative service delivery.** This symposium will examine the current international regulatory framework for the authorization of alternative service delivery (ASD) in the context of phytosanitary regulation. It will explore the circumstances under which National Plant Protection



Organizations employ third-party services, including the advantages and challenges associated with this approach. Finally, the symposium will look at the current industry experience and best practices in an ASD framework.

In addition, several knowledge topics on important and timely phytosanitary concepts such as **Host Status** will also be part of the meeting. The NAPPO Secretariat has invited colleagues from international plant health organizations such as the International Plant Protection Convention and the Interwill be presenting their results or updates during the meeting. These are Asian Gypsy Moth, Biological Control, Diversion from Intended Use, ePhyto, Forestry – 2 projects, Grains – 2 projects, Khapra Beetle, Likelihood of Establishment, Lymantriids, Phytosanitary Alert Systems, Potato – 3 projects, Risk-Based Sampling, Seed, and the NAPPO Advisory and Management Committee.

# International Symposium on Risk-Based Sampling

NAPPO and our key partners are pleased to announce the International Symposium on Risk-Based Sampling to be held in March 2017. The purpose of the Symposium is to bring together government agencies, researchers and analysts, industries and international organizations to collaborate in the development and implementation of Risk Based Sampling methods for phytosanitary inspection.

### Vision

NAPPO and our key partners recognize the need for phytosanitary measures to be technically justified and based on phytosanitary considerations. Risk-Based Sampling provides a method for countries to implement ISPMs and ensure measures are consistent with international obligations.

The International Symposium on Risk-Based Sampling (RBS) will promote:

- International collaboration to frame agricultural quarantine policy around RBS.
- A universal understanding of RBS concepts and their application in practice.
- A scientific understanding, an operational and regulatory strategy, and a collaborative approach to RBS and Risk-Based Quarantine Policy.
- Implementation of ISPMs and technically justified inspection procedures used in trade.
- Communication strategies for

fostering acceptance of RBS by decision-makers and stakeholders.

### Who should be involved?

- Researchers in the field of inspection, risk, risk perception, and risk-based regulatory design
- Agricultural quarantine or exclusion policy managers
- Analysts and statisticians involved in risk analysis work for agricultural exclusion programs
- Trainers and training developers tasked with creating agricultural inspection curriculum
- Front line supervisors, officers, and technicians involved in day-to-day agricultural exclusion activities
- Senior administrative executives and senior policy executives interested in risk-based regulations
- Students interested in pursuit of risk-based regulatory design or risk -based sampling schemes in an agricultural environment
- Trade policy administrators and managers
- Importers, exporters, and brokers involved in international trade

The first change you will start to see is that web-based meetings will be run through Momentum Telecom conferencing. This platform allows for improved and simpler connections to web-based conference calls for all participants and is compatible with a wide variety of computer systems and Government firewalls. Anyone with an internet connection should be able to easily and quickly access webconferencing with the Momentum Telecom conferencing service. The second change you will see is the use of Google Docs to securely store, retrieve, edit, and seamlessly share documents that Expert Groups are working on. Like the Momentum Telecom conferencing service, anyone with an internet connection should be able to access Google Docs.

We continue to explore these new platforms as a way to better serve the three NPPOs and other NAPPO stakeholders. We would also welcome feedback to the Secretariat if you use these programs – how well do they work for you? Have you encountered any problems? Do you have any suggestions for improvements?
