Item 1/ Asunto 1:	Review of document discussed on October 7, 2016 by EG members from Mexico and Canada.	
Consensus/Decisiones:	<p>The final version of the DFIU document was discussed on October 7, 2016 in a conference call where EG members from Mexico and the United States participated. Because Canada could not participate in that meeting, and because the US and Canada had previously agreed on the content of the DFIU document, this meeting (October 11) was carried out to have Canada and Mexico discuss the final version of the DFIU document and have all representatives from the three NAPPO countries reach a consensus and approval on next steps.</p> <p>The next steps will be – the Secretariat will clean-up the document in English and make it available to the group. Aidee will clean-up the document in Spanish, ensuring that the translation is OK for Mexico. The document will be reviewed and final approval will be given on Oct. 20 – during the EG next call.</p>
