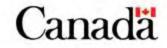

<u>Political</u>

- Clearly defined objectives of ePhytos
- Funding

<u>Management</u>

- Financial commitment
- Involve other business lines (i.e., Animal Health)
- Clearly understand advantages and costs

<u>Industry</u>

Support from industry

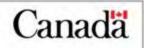




Initial Support (continued)

Financial

- Short Term
 - Designing, building the system
- Long Term
 - Changes / updates (of system and underlying data)
 - Enhancements to user interface
 - Updating foreign country import requirements
 - Maintenance

- What are the benefits to implementing electronic certification?



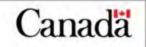


Impacts on current system

National legal/regulatory system:

- Does anything need to be adjusted or changed?
- Paper required under legislation?
- Electronic forms acceptable?
- Electronic signatures?



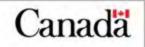


Impacts on current system (continued)

- Costs vs benefits (adjust expectations)
 - initial expense vs. long term savings

Long term financial commitment for future IT development and maintenance





Impacts on current system (continued)

- Can your existing system be modified?
- Can you use an existing third-party system?
- Build a new system? (e.g., building new import/export system, add ePhyto)
- Integrated into a "One Window" (WCO) approach?



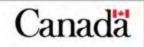


User support

Switch to electronic systems from paper

- Clearly explain advantages to users
- Exporter-entered data
 - Reduces time needed for NPPO staff to enter data
- Facilitates generation of data summaries
- Have both ePhyto and paper





IT Support

Well-defined user requirements and functional specifications

 Defined by phytosanitary business in consultation with an IT business analyst





IT Support

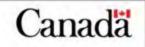
Sufficient System Capacity

Storage, speed

User equipment

- Implementation dependent
- May include laptops, tablets for field use (cell or wi-fi connections)

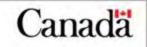




Impact on current phytosanitary programs

- Preclearance agreements
- Third party agreements
- Others





Bilateral agreements

- Consider the terms of reference for bilateral agreements
- Who needs access

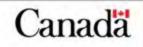




Final Considerations

 Use business point of view to ensure official phytosanitary assurances are transferred effectively and efficiently (do not go beyond regulations)





Final Considerations (continued)

- Make use of experience of other countries (e.g., study tours, experiential learning, etc.) – don't reinvent
- Make use of FAQs developed by the ePhyto Expert Group
